### CMS Website Features Enforcement Database

The Centers for Medicare & Medicaid Services (CMS) has made available a database with enforcement information. In August 2017, CMS announced the Quality and Certification Oversight Reports (QCOR) website launch in an intiaitive for increased transparency. The QCOR website is meant for providers, suppliers, and stakeholders to have better access to data. The QCOR website launch replaces the previously known Survey and Certification Providing Data Quickly (S&C PDQ) system. S&C PDQ provided summarized survey and certification data, including results of on-site inspections of providers and suppliers. The QCOR site is meant to be more easily accessible. It provides the results of CMS survey and certification activity over the last 10 years. The QCOR website can be accessed at https://qcor.cms.gov.

# New Training Materials on Abuse and Revised Nursing Home Regulations

Consumer Voice and NORC have created several new training materials on the topic of abuse, neglect, exploitation and misappropriation of property. The materials are based on the revised nursing home regulations.

The new materials can be used together as an educational toolkit for training by and for Ombudsman program representatives, for members of resident and family councils, facility in-service training and community education.

- Prezi A Prezi is a visual storytelling alternative to a PowerPoint presentation. The Abuse, Neglect, Exploitation and Misappropriation of Property Prezi uses the map-like layout to provide information on identifying, preventing and reporting abuse and knowing the signs of abuse. The Prezi is available as a <u>video with a voiceover</u> or as a <u>clickable</u> <u>presentation</u> without the voiceover. Use the <u>script</u> to follow along with the presentation and learn further details on each topic.
- PowerPoint This <u>PowerPoint</u> can be used for training purposes. The slides include presenter notes and are customizable for state and local information.
- Fact Sheet This updated <u>fact sheet</u> is an easyto-use handout with information on the topic.
