

## NASUAD FY18 Budget Chart: Key HHS Programs Serving Seniors and Persons with Disabilities As of March 22, 2018 (Dollars in Millions)

Please note: this chart specifically focuses on the FY2018 Omnibus bill that was released on March 21<sup>st</sup>, 2018 and is likely to be enacted by March 23<sup>rd</sup>. However, because the FY2019 President's budget was released in February, we include it for reference despite the fact that it covers a different fiscal year. In the chart below, numbers in **green** indicate an increase from the FY2017 enacted levels and numbers in **red** indicate a decrease.

<sup>4</sup> Includes funding for both the Long-Term Care Ombudsman program and the Prevention of Elder Abuse & Neglect programs. The FY18 Omnibus provided a \$1 million-dollar increase. The FY19 President's budget proposed to level-fund them.

<sup>5</sup> The FY17 Omnibus Appropriations act does not specifically provide money for the Senior Medicare Patrol Program, but instead include language directing HHS to fully fund it via the Health Care Fraud and Abuse account. The FY18 Omnibus continues to fund the Senior Medicare Patrol program using the same mechanism.

<sup>6</sup> The FY18 House and Senate appropriations bills also direct HHS to fully fund SMP via the Health Care Fraud and Abuse Account but do not directly appropriate funding for the program.

<sup>7</sup> The FY18 and FY19 Budgets proposed to consolidate all Alzheimer's disease activities across ACL into a single grant program, funded at \$19 million.

<sup>8</sup> The FY19 Budget proposes moving this program from ACL to NIH, and alters funding levels to \$95 million.

<sup>10</sup> The FY19 Budget proposes to eliminate the \$47 million in dedicated SHIP funding. However, the budget also proposes to maintain \$38 million for ADRCs, AAAs, the National Center for Benefits Outreach and Enrollment, and the SHIP program authorized by MIPPA.

<sup>11</sup> The appropriations bill specifically allocates \$12.46 million for Aging Network Support Activities, but directs ACL to spend \$5 million on the Holocaust Survivor's Assistance program. For clarity,

<sup>13</sup> The President's FY18 Budget Requests contained a new block grant—*America's Health* Block Grant Program—that allocates \$500 million to states to implement state-specific interventions to address leading causes of death and disability, such as heart disease and stroke, and diabetes. The House and Senate appropriations bills did not include this item in FY18. The FY2019 budget contains the same proposal.

<sup>14</sup> The Senate Appropriations bill level funds the three CNCS programs but does not distinguish individual funding levels for each.

<sup>15</sup> The President's budget proposes eliminating the Corporation for National and Community Service, which would also eliminate all of the programs listed here. The remaining funding in FY2019 would be provided for close-out activities and the programs would not receive any funding in subsequent years.
