



## The Moving Forward Coalition needs you! Together, we can improve quality of life for nursing home residents.

### Our Vision:

Every nursing home resident deserves to live in a safe and comfortable environment that honors their values and preferences, promotes equity, and supports staff with the resources and training to provide high-quality care and support.

The Coalition, funded by The John A. Hartford Foundation, is working to improve how the United States finances, delivers and regulates care in nursing homes. We will drive specific, practical, and actionable improvements in nursing home quality in the next one to two years, while building a sustainable collaborative to continue moving the work forward.

### Our Four-Phased Approach:

Moving Forward is comprised of a diverse group of leaders, including nursing home residents, staff, policymakers, and advocates. Below is our approach and timeline.



### Phase 1 - Convene: Committees organized over the summer

- A Steering Committee was established and includes several members who helped write the *National Imperative to Improve Nursing Home Quality: National Academies of Sciences, Engineering and Medicine (NASEM) Report*.
- Seven working committees were created to address the seven goals outlined in the NASEM Report. Each committee includes a nursing home resident and a CNA to ensure a holistic perspective.
- Nearly 300 individuals have signed up as Committee Members, subject matter experts (SMEs), residents/family members, or as individuals interested in making a difference.

### Phase 2 – Prioritize Recommendations:

- Committees will identify and prioritize 1-2 recommendations and will post priority recommendations on the Coalition website to elicit input starting in November.

### **Phase 3 - Create Action Plans:**

- Committees will engage a diverse group of federal and state policymakers, advocates, nursing home leaders, and residents, as well as other SMEs in crafting and reviewing these plans. Coalition leadership will host discussions for feedback.

### **Phase 4 - Test & Promote Action Plans:**

- The Coalition will organize policymakers, nursing home staff, and other leaders to test and promote action plans.

### **Ways Nursing Home Residents, Staff & Others Can Contribute:**

- Everyone can provide input into Priority Recommendations and Action Plans
- Nursing homes and other organizations may partner with the Coalition to test ideas in the Action Plans
- Nursing Home residents, staff, and advocates will have opportunities to engage with policymakers to discuss Coalition-recommended actions
